Under the following conditions:

- A SERVICE FEE OF \$3000.00 + gst** will be payable upon notification of an official 42 day positive manual or scanner pregnancy test. Should the mare test positive but leave the Stud prior to a 42 day test, the service fee becomes payable on departure.
- The Live Foal Guarantee (Free Return)** will be provided by the Stud (as per the conditions set out below) for any mare that returns a positive test at 42 days whether by manual or scanner examination by a qualified Veterinary Surgeon.
- Live foal guarantee conditions are as follows:-**
A free return will be made to the Mare Owner until their mare produces a live foal insurable at 24 hours PROVIDED
 - That the full Service Fee has been paid within 30 days of the issue of our invoice.
 - That the Mare has been foaled under approved 24 hour supervision at a recognised stud establishment.
 - The loss of the foetus or the death of the foal has taken place on or before the expiry of 24 hours from the time of birth of such foal.
 - That all claims under this guarantee must be accompanied by a veterinarian's report and certificate of the time and cause of death.
 - That if the mare slips or fails to produce a live foal, the Free Return will only be provided on production of a Veterinary Certificate stating that the mare had undergone an Equine Herpes Virus Vaccination Programme.
 - That if the mare dies from natural causes during the term of pregnancy, the Free Return service will be provided to an approved mare nominated by the owner.
 - That if the mare is transported overseas or sold during the term of pregnancy then the Live Foal Guarantee is forfeit.
 - In the case of Walk-In mares slipping or producing twins, the Live Foal Guarantee does not apply if the mare was not scanned for twins by a qualified Veterinary Surgeon within 27 days of Service and corrective measure taken if necessary. NOTE Mare Owners should insure their foals from expiry of the 24 hour period to protect their investment re: Service Fees etc.
- All VETERINARY CHARGES** are the responsibility of the mare owner and will be charged direct to the mare owner by the Vet.
- The stud reserves the right to withhold service from any mare in the interests of hygiene or staff safety.
- The Proprietor retains the right to breed the mare up until the conclusion of the breeding season, ie 31 December and that when the Mare Owner and Proprietor agree, the season can be extended for a further period.
- OTHER CHARGES**
 - A Foaling Fee of \$400 will be charged.
 - An agistment fee will be charged at the following rates from the date of arrival to the date of departure inclusive:-
 - Dry mares \$5.00 per day + gst
 - Mares in foal/with foal at foot \$7.50 per day + gst
 - When extra supplementary feed is needed, an additional charge will be made.
 - Drenching, Farrier and other costs incurred will be charged to the mare owner.
- MARE ARRIVALS** at the stud are as follows:-
 - Dry mares as close to 30 August as practical
 - Wet mares to arrive approximately 3 weeks before foaling
- For** the period of time that your mare and foal are on our property we undertake to give all possible care and attention, but accept no responsibility should any accident or sickness occur.
- INTEREST** at the rate of 2% per month will be charged and payable on all amounts unpaid by the end of the month following the month of issue of our invoice(s).
- It is the express condition to this contract that the Proprietor be entitled to a lien over the mare and/or progeny irrespective of any fees for agistment or service of the mare and/or progeny which are outstanding and further the Proprietor shall have the power to sell the mare and/or progeny over which such lien is taken to recover outstanding fees should the same not be paid with ninety (90) days after the account has been rendered and in this respect the Mare Owner appoints the Proprietor as his Attorney with the power to sell the mare and/or progeny if such fees are unpaid as aforesaid. Should the mare and/or progeny have left the stud property, then the proprietor shall have the right to uplift the mare and/or progeny regardless of the location of said mare and/or progeny).
- DOCUMENT OF DESCRIPTION** must accompany broodmare.
- MARES will NOT be served without a signed contract.**
